

SOUTH WHITEHALL TOWNSHIP BUSINESS PRIVILEGE APPLICATION

South Whitehall Township requires anyone conducting business within the Township to obtain a Business Privilege License at a cost of \$10.00 for a new license or \$5.00 for a license renewal should the vendor already hold a current license. This includes all vendors participating in events held at the Pennsylvania Expo Center, 501 Cetronia Road, Allentown, PA 18104.

An application is enclosed for your convenience. Please follow the instructions on Page 1, answering all questions pertaining to the activity performed in the South Whitehall Township. It is most important to list your name, business name, if applicable, business/home address, description of business/profession including products sold or services provided. Before mailing to the Pennsylvania Expo Center, sign the application on Page 3, and then return with \$10.00 fee for a new license. Your application should be received at the Township office no later than two (2) weeks before the event. A license will be sent to you as soon as possible upon approval from our Zoning Office.

Also, the Township collects a Business Privilege Tax. The amount of tax due is calculated on gross receipts (rate of .00150 or 1-1/2 mills (\$1.50 per one thousand dollars) for retail/service business and (.00100 or 1 mill (\$1.00 per thousand dollars) for wholesale business transacted within the territorial limits of the Township. A form will be sent at the end of the year for reporting gross receipts and renewal of the Business Privilege License for the New Year.
